2024 Earlybird RV Show Contest

CONTEST RULES

1. Contest Period

The 2024 Earlybird RV Show by Fraserway RV Contest (the "**Contest**") begins at 10:00:00 a.m. Pacific Time ("**PT**") on February 22, 2024 and ends at 5:00:00 p.m. PT on February 25, 2024 (the "**Contest Period**"). By participating in the Contest, each entrant agrees to abide by and be bound by these Contest Rules and all decisions of MTD Promotions, a division of Fraserway RV LP (the "**Sponsor**"), which shall be final and binding, without right of appeal, in all matters relating to this Contest and the awarding of the prizes, including without limitation eligibility and/or disqualification of entries.

2. Eligibility

The Contest is open to all Canadian resident attendees (excluding residents of Quebec) of the 2024 Earlybird RV Show and Sale at Tradex in Abbotsford, British Columbia (the "**RV Show**") who are at least nineteen (19) years old at the time of entry.

Excluded from eligibility are the officers, directors, employees, agents and representatives of the Sponsor and its parents, subsidiaries, affiliates, advertising and promotion agencies, (collectively, the **"Contest Entities"**), and members of the immediate families (defined as parents, siblings, children and spouses, regardless of where they live) or households (whether or not related) of such officers, directors, employees, agents and representatives.

3. How to Enter

NO PURCHASE NECESSARY.

Entrants may obtain one (1) entry into the Contest by using one of the following methods of entry:

a) Purchase Method:

- i) enter into a valid and complete agreement for the purchase of an RV at the RV Show prior to entry; and
- complete a ballot form provided at the RV Show setting out the entrant's name, province of residence, age, and telephone number and an indication that they have entered into an agreement to purchase an RV at the RV Show and submit it at a marked location during the Contest Period.
- **b)** No-Purchase Method: If an entrant does not wish to purchase an RV at the RV Show, they may enter the contest by completing a ballot form provided at the RV Show with the following information and submit it at a marked location during the Contest Period:
 - i) the entrant's name, age, province of residence, and telephone number;
 - ii) a 500-word essay describing what they love about the RV lifestyle; and
 - iii) the name of at least one (1) dealership in attendance at the RV Show.

Limit: one (1) entry per person during the Contest Period, regardless of entry method used.

4. Prizes

There is one (1) prize available to be won, consisting of CAD\$5,000 to be awarded in the form of a cheque.

Prize must be accepted as awarded and may not be substituted or transferred, except at Sponsor's sole discretion. Sponsor reserves the right, at its sole discretion, to substitute a prize of greater or equivalent monetary value if a prize cannot be awarded as described for any reason. Sponsor will not replace any lost or stolen prize. Any other costs or expenses associated with the prizes not specified herein will be the responsibility of selected winner. The cheque representing the prize must be deposited within the applicable required time period deemed acceptable by the winner's bank ("**Stale Date**"). Any cheque prize that is past the Stale Date will not be substituted or replaced by Sponsor. If the winner entered the Contest using the Purchase Method, the prize will be delivered to the verified winner at the time of delivery of their RV. If the winner entered the Contest using the No-Purchase Method, the prize will be available for pickup by the verified winner at the Fraserway RV dealership located at 30440 South Fraser Way, Abbotsford, BC until March 4, 2024. Failure to claim the prize by March 4, 2024 will result in forfeiture of the prize.

5. <u>Winner Selection</u>

On or about February 25, 2024 at the RV Show between 5:00 p.m. PT and 10:00 p.m. PT (the "**Draw Date**"), a random draw will be conducted from among all eligible entries received during the Contest Period for the purpose of selecting one (1) potential winner (subject to satisfying the prize claim conditions below). Odds of being selected depend on the number of eligible entries received during the Contest Period.

6. Selected Entrant Verification and Prize Claim Conditions

Selected entrants will be notified by telephone call at the telephone number provided at the time of entry before 10 p.m. PT on the Draw Date. Sponsor or Sponsor's agent will make two (2) attempts to contact the selected entrant. In order to be declared a winner, the selected entrant must first: (a) respond to notification of selection by answering the Sponsor or Sponsor's agent's telephone call; (b) sign and return to Sponsor, within two (2) business days of it being sent by Sponsor, a written declaration and release form, releasing the Contest Parties and each of their respective officers, directors, employees, agents, representatives, successors and assigns (collectively, the "**Releases**") from any liability in connection with this Contest or the use, misuse, awarding or possession of the prize (the "**Release**"); (c) correctly answer a time-limited mathematical skill-testing question, without assistance or mechanical aid, which will be provided on the Release; (d) in the case of entry by the Purchase Method, complete the purchase of the RV (i.e. meaning that funds have been transferred to the RV vendor as required by the RV vendor to complete the sale); and (d) otherwise comply with these Contest Rules.

If the selected entrants cannot be contacted when the Sponsor calls on the Draw Date; the selected entrant fails to provide proof of eligibility, including an executed RV purchase agreement or receipt for purchase (if requested); the selected entrant fails to provide an executed Release as required or

other required documentation in a timely manner; the selected entrant fails to answer the skill-testing question correctly; or the entrant otherwise does not comply with these Contest Rules, then the selected entrant will be disqualified and the Sponsor reserves the right, in its sole discretion, to randomly select an alternate eligible entrant from among the remaining eligible entries, who will be subject to disqualification in the same manner.

7. Right to Void / Terminate / Suspend / Modify

Sponsor reserves the right to terminate, suspend or modify this Contest, in whole or in part, at any time and without notice or obligation for no reason or for any reason, including if, in Sponsor's sole discretion, any factor interferes with its proper conduct as contemplated by these Contest Rules. Without limiting the generality of the foregoing, if the Contest, or any part thereof, is not capable of running as planned for any reason, including but not limited to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, programming errors, or technical failures, which, in the sole discretion of Sponsor, corrupt or affect the administration, security, fairness, integrity or proper conduct of this Contest, Sponsor may, in its sole discretion void any suspect entries and: (a) terminate the Contest, or any portion thereof; (b) modify or suspend the Contest, or any portion thereof, to address the impairment and then resume the Contest, or relevant portion, in a manner that best conforms to the spirit of these Contest Rules; and/or (c) award the prize from among the eligible, non-suspect entries received up to the time of the impairment in accordance with the winner selection criteria discussed above.

Sponsor reserves the right at its sole discretion to disqualify any entrant who tampers or attempts to tamper with the entry process, the operation of the Contest, violates the Contest Rules, or acts with intent to annoy, abuse, threaten or harass any other person.
